DPNS PLAYGROUPS

The DPNS Playgroup program is designed to meet the needs of toddlers and their parents. The program offers children a special environment where it is recognized that while they are no longer “babies,” they are not yet ready for the world of preschoolers. A teacher experienced in working with young children directs the playgroups, and presents activities geared to the developmental needs of toddlers. Children have the opportunity to experience and experiment with a rich variety of activities, and parents have the opportunity to meet with other parents for fun and support.

We offer two types of playgroups: Mixed-age Playgroups for younger toddlers from age 15 months to 2 years 3 months, and an Older Playgroup for children from age 2 to 2 yrs 9 months. Children must meet the minimum age by end of August, or can enroll as openings occur later in the year if their age is within the range (Mixed-age Playgroups only).

The Older Playgroup meets at our Danbury site on Monday afternoon. Two Mixed-age Playgroups meet at our 8th Street site on Friday afternoons. A Monday 3pm Mixed-age Playgroup is also offered at our Danbury site. See details on reverse.

Make-up sessions are offered on a regular schedule. Each playgroup is limited in size to eleven children and the parents or guardians who attend with them.

***FAMILY EDUCATION TIME (FET)**

DPNS is an Adult Education class in the Davis Joint Unified School District. DPNS receives funding from the State for the number of parent participation hours acquired through parent attendance at DPNS-sponsored or scheduled educational programs and lectures, extra participation or observation days, and other DPNS Director-supervised events during the school year.
