

## DPNS Extended Day Friday, Friends, and Fun!

The Extended Day Program offers children from all DPNS programs the opportunity to meet with friends for lunch and outdoor play on Friday afternoons at the 8th Street site. The program currently accommodates 14-16 regular students with a 3 hour minimum attendance and payment. The program also accommodates 4 playgroup siblings (2 spots for children with younger siblings in the Friday 1pm playgroup and 2 spots for children with younger siblings in the Friday 3pm playgroup) with a 2 hour minimum attendance and payment. Extended Day is staffed by a Director and one to two assistants. **There is no parent participation requirement.**

### **Extended Day Program Information**

***Time and Location:*** Fridays from 11:45 am to 4:30 pm at the 8th Street site.

#### ***Participant Requirements:***

- Minimum age of 3yr, 3mo at time of enrollment. No students in first grade or above can be enrolled in Extended Day.
- Students must be potty trained.
- Each child brings her/his own lunch and snack (no peanuts or tree nut products).
- There are no parent participation requirements.

#### ***Applications Deadline***

Applications must be postmarked by June 15 to be considered in the first round of enrollment (see policies below.) Applications received after the deadlines will be considered on a first come first served basis.

***Tuition for Regular Students:*** The cost is \$9.00 per hour with a 3-hour minimum payment requirement (2-hour minimum payment requirement for designated playgroup spots). If a family enrolls more than one child, the rate for additional child(ren) is \$4.50 per hour. Fees will be billed and collected at the end of each month. Please make checks payable to DPNS.

***Drop In Spots:*** There may be a limited number of drop-in students accepted if there are cancellations from regular students or vacancies. Drop-in fees are as above, but payment for the day is required at the time a drop-in student is picked up from the program. Please make checks payable to DPNS.

***Absences:*** For regularly enrolled students and regular playgroup spots, tuition will not be refunded for absences with less than 24 hours notice. A partial or full refund may be given if a parent provides more than 24 hours notice of an absence at Directors' discretion.

## **Extended Day Enrollment Policies**

- The program currently accommodates 14-16 regular students for a 3 hour minimum and 4 playgroup siblings (2 spots for children with younger siblings in the Friday 1pm playgroup and 2 spots for children with younger siblings in the Friday 3pm playgroup) for a 2 hour minimum.
- Drop-in spots are available when regular spots are not filled or when there are student absences. A drop-in list will be maintained, and families will be contacted when vacancies are available. Eligible families simply need to make contact with the director and have enrollment paperwork filled out to be added to the drop in list.
- There will be four regular spots held for Playgroup siblings, guaranteed for the full year. Priority enrollment for these spots is: 1) currently enrolled DPNS student, 2) DPNS alumni/kindergarten student, and 3) all other students. Playgroup siblings may also apply for a guaranteed 3-hour minimum spot, or attend as a drop-in student (2-hr minimum.) No students in first grade or above can be enrolled in Extended Day.
- All other regular student (3 hour minimum) spots are guaranteed for the full year. Priority enrollment for these spots is: 1) currently enrolled DPNS student, 2) DPNS alumni/kindergarten student, and 3) all other students. Again, no students in first grade or above can be enrolled in Extended Day.
- If spots remain open after the application deadline, they will be filled on a first-come, first-served basis.
- If demand exceeds program capacity after the June deadline, a lottery will be held.
- Enrollment is always at Director's discretion.
